In order to prepare for this election, we are seeking qualified candidates that are willing to serve as the homeowner representative on the board of directors for the RedHawk Homeowners Association, Inc. ("Association")

QUALIFYING FOR THE BOARD:

Any owner who wishes to run for the board of directors must provide the Association with written notice by mail or in person of your intent to run no later than 5:00 PM on Friday, September 14th, 2018. The enclosed "Notice of Intent to Run for the Board of Directors" form for shall be used for this purpose. Any intent to run forms postmarked or dropped off after this deadline will not be permitted to be on the ballot. The address for mailing or dropping of your intent to run form is below.

You may submit an **Information Sheet** containing your qualifications and/or platform for office with your intent to run form. Your qualifications must be provided on a page no larger than 8-1/2 inches by 11 inches and you may use only one (1) side of this sheet. This Information Sheet must be submitted to the Association or postmarked by **5:00 PM** on **Friday, September 14th, 2018**. Any Information Sheet postmarked or dropped off after this deadline will not be included on the ballot.

We will also mail ballots to each the homeowners with the candidates listed and their Information Sheets included. Please keep an eye on the website for updates as we get ready for this election. PROXY INFORMATION:

It is imperative that every homeowner returns their signed proxy (attached) by Friday, September 28, 2018. The proxy will be used to establish a quorum so that a vote may be held to elect an owner to the Board of Directors. If we do not have a quorum, then the election will not occur. The proxy is NOT used to cast your vote for the next Board Member. Only completed and returned ballots (once mailed to the owners) and homeowners in attendance will be permitted to vote. Homeowners may collect a neighbor(s)' proxies and bring them to the meeting in person if needed.

PLEASE NOTE: UNDER THE PROVISIONS OF FLORIDA STATUTE 720.306(9)(b):

A person who is delinquent in the payment of any fee, fine, or other monetary obligation to the association on the day that he or she could last nominate himself or herself or be nominated for the board may not seek election to the board, and his or her name shall not be listed on the ballot. A person serving as a board member who becomes more than 90 days delinquent in the payment of any fee, fine, or other monetary obligation to the association shall be deemed to have abandoned his or her seat on the board, creating a vacancy on the board to be filled according to law. For purposes of this paragraph, the term "any fee, fine, or other monetary obligation" means any delinquency to the association with respect to any parcel. A person who has been convicted of any felony in this state or in a United States District or Territorial Court, or has been convicted of any offense in another jurisdiction which would be considered a felony if committed in this state, may not seek election to the board and is not eligible for board membership unless such felon's civil rights have been restored for at least 5 years as of the date on which such person seeks election to the board. The validity of any action by the board is not affected if it is later determined that a person was ineligible to seek election to the board or that a member of the board is ineligible for board membership.
